New Nuncio

His Holiness Pope John Paul II nominated His Excellency Monsignor GIAN VINCENZO MORENI Apostolic Nuncio to the Philippines. The appointment was announced on Saturday, September 8, 1990 in Rome at 12 noon corresponding to 6 p.m. local time.

Archbishop Moreni was born on January 29, 1932 in Montichiari, Brescia (Italy). He was ordained priest on April 4, 1959.

He has a doctorate in Canon Law and entered the Diplomatic Service of the Holy See in 1963. He has served in the Pontifical Representations in Formosa, Thailand, the Dominican Republic, Lebanon, and in the Council for the Public Affairs of the Church (Vatican City).

He was appointed Apostolic Pro-Nuncio to Tanzania on April 4, 1982 and was consecrated Archbishop on June 5, 1982.

He arrived in Manila on November 25, 1990.

he Church, as any other living organism either renews and adjusts herself to the environmental conditions or perishes. She must enter into a dialogue with modern society which constitutes her environment in order to revitalize herself in a living way, that is, from within. The Second Plenary Council of the Philippines is an attempt of the Philippine Church to renew herself from within. The Council signifies a conscious effort of the Church to adapt herself to the condition of modern life. The Council also hopes to provide an answer to the needs affecting the Philippine Church.

But any adaptation of a living being to its environment must be done according to the nature and specific characteristics of such a living organism. A radical change, a specific modification demands the death of the old and the emergence of a new being with new life. The renovation of the Philippine Church aims to adapt herself to the living conditions of modern times within the framework of her nature and mission. It is a renewal and not a radical change which would transform the old Church into a new one. This renovation as envisioned by the Second Plenary Council of the Philippines means: first, to strengthen the faith in Christ and his Church of the Christian Community; and second, to restore the moral and Christian sense in the Philippines by issuing norms and directives which will serve as channels to adjust Christian life to the world of today. Thus, the Second Plenary Council motto is: "To restore all things in Christ."

The Boletin Eclesiastico de Filipinas conscious of its mission of being the official organ of the hierarchy dedicates this issue to the

Second Plenary Council of the Philippines. In its pages you will find all the official documents and relevant information pertaining to the Second Plenary Council's preparatory phase, except the working or position papers of the different committees. To give way to this momentous event of the Philippine Church all other sections in the Boletin are suspended except the Consultative Words and God's Word for Tomorrow.

Petition Letter for the Permission to Convoke the Second Plenary Council of the Philippines

CBCP, Manila, August 1, 1988

Your Eminence:

Prayerful greetings in Christ!

lease know that the First Plenary Council of the Philippines was held in 1953, thirty-five years ago, when there were but 6 Archdioceses, 14 Dioceses, 2 Vicariates and 5 Prelatures. There were then but 2 Auxiliary Bishops and some 27,000,000 baptized Catholics.

Since then, the Second Vatican Ecumenical Council was celebrated, the new Code of Canon Law was promulgated, and 7 Synods of Bishops and 2 Extraordinary Synods were convoked.

To date, the Church in the Philippines is composed of 16 Archdioceses, 49 Dioceses, 5 Vicariates and 5 Prelatures. There are now 20 Auxiliary Bishops and some 52,000,000 baptized Catholics.

In addition to the above salient change in the pastoral situation of the Church in the country on account of the said ecclesiastical factors, there is also the marked change in the societal condition of the Philippines due to the advent of a rather new Government brought about by a peaceful revolution.

These changes, needless to say, bring distinct advantages as well as significant problems that urge the review of and resolve on the proper pastoral orientation that the Church in the Philippines should adopt on the national level for the decade of the 1990's.

Wherefore, in their plenary meeting held in January of this year, the Catholic Bishops' Conference of the Philippines already signified their option to hold the Second Plenary Council of the Philippines after due preparations — an option which was overwhelmingly reaffirmed this time in writing during their last plenary meeting held in July also of this year.

In the name of the same Catholic Bishops' Conference of the Philippines, therefore, I beg to be allowed to seek the approval of the Apostolic See for the celebration of the Second Plenary Council of the Philippines as provided by Canon 439 par. 1 CIC.

Upon receipt of the Rescript of Grace, your kind Office shall be provided with more particulars that will be made available in the course of the formal, thorough and adequate Preparation Phase.

DECREE OF CONVOCATION SECOND PLENARY COUNCIL OF THE PHILIPPINES

"Unite all things in Christ" (Eph 1:10)

eading the signs of the times in the light of the Good News of Jesus Christ, considering the joys and fears, the hopes and pains of the Filipino People in the spirit of Christian solidarity and compassion, invoking the grace of Divine Providence and calling upon the goodwill of the Christian Faithful, We Cardinals, Archbishops and Bishops gathered in Plenary Assembly as the Catholic Bishops' Conference of the Philippines, with the approval and affirmation of the Holy See, hereby formally announce the convocation of the Second Plenary Council of the Philippines from 20 January to 17 February 1991, and herewith officially proclaim 1991 as the "Year of the Second Plenary Council."

In line with the pronouncements of the Second Vatican Ecumenical Council that was a New Pentecost for the Church, and in accord with the provisions on the Pastoral Office of the Bishops in the Church that endorse the convocation of Councils for the growth of the Faith through collegial actions and common programs, We have made the definite and defined pastoral option to hold the Second Plenary Council of the Philippines with the promotion and the renewal of the Filipino Christian life through Christ, with Christ and in Christ, as its primary ecclesial objective.

Signal and singular Church assemblies like Plenary Councils are held during peak movements (sic) in the life of the local Church and also during critical times in the history of the Country where the Church is incarnated.

Thirty-seven years have passed since the celebration of the First Plenary Council of the Philippines in 1953. Since then, significant ecclesial and national events and changes have taken place. Distinct promising factors as well as serious problematic issues accompanied these new religious and social situations. They now rightfully demand particular and concerted pastoral attention.

The extraordinary importance of the forthcoming Second Plenary Council of the Philippines is premised on its highly relevant and actual seven-point agenda that came to fore through nationwide surveys of all the sectors of representative Christian Faithful. The seven general topics that the Council shall address are Christian Life, Religious Concerns, Church and Society, Laity, Religious and Clergy. Seven Conciliar Commissions have been established to serve as lead agents in the study, discussion and deliberation on these seven topics.

All these seven conciliar topical agenda should be studied, discussed and deliberated upon with the following four directional features: Uniting Focus is Christ. Orientation is pastoral. Context is Filipino. Spirit is Evangelization 2000.

To ascertain extensive consultation with and participation of Christ's Faithful in the study and discussion of the agenda prior to the decisive deliberation thereupon by the Plenary Council, "Working Papers" prepared by the Conciliar Commissions on the seven topics shall be disseminated nationwide for comments and recommendations.

Wherefore as dictated by ecclesial communion and compelled by our episcopal Office, We ardently call upon the Christian Faithful all over the Country to unceasingly pray for the pastoral success of the Plenary Council specially during the Lenten Season, a time of penance and sacrifice, and to spiritedly participate in the consultation on the conciliar agenda through their Pastors.

Finally, as provided by Church Law and determined by the Catholic Bishops' Conference of the Philippines, We unequivocally enjoin all formally summoned Bishops, Vicars, Rectors, Deans, Major Superiors of Religious and Apostolic Institutes, Laymen and Laywomen, to attend the Plenary Council in representation of their respective particular Ecclesiastical Jurisdictions.

Firmly united in Christ, ardently praying and decidedly laboring for all things to be united in Christ, We commend the Second Plenary Council of the Philippines to the loving care of the Father and the gentle guidance of the Holy Spirit for the good of the Church and the welfare of the Country. Amen.

SECOND PLENARY COUNCIL OF THE PHILIPPINES DIRECTORY

Section I: General Norms

1. Competence of the Episcopal Conference

he right to convoke a Plenary Council belongs to the concerned Episcopal Conference with the approval of the Apostolic See. The following are the prerogatives of Episcopal Conferences with reference to the celebration of Plenary Councils:

- a. To specify the dates of its celebration, to officially convoke and conclude it.
- To determine the site of its celebration.
- c. To elect the President of the Council from among the diocesan Bishop-members of the Conference and to present the same to the Apostolic See for approval.
- d. To determine the subject matter to be considered and deliberated upon by the Council and to decide on the order of business to be followed.
- e. To transfer the site of the Council when needed, to prolong or end it prematurely when grave reason so requires.

The Conference may exercise its pertinent prerogatives at any time even during the very celebration of the Council. Hence, duly convoked, the Conference can legitimately meet emergency situations and respond to contingencies affecting the Council members, the proceedings and the achievement of the objectives of the Council.

2. Membership and Participation

There are three kinds of Council members with different categories of participation in the Council: members with the right to be summoned, members who may be called, and members who could be invited.

- a. The following are members with the right to be summoned:
 - (1) All Diocesan Bishops (cc. 368, 381 CIC)
 - (2) All Coadjutor Bishops
 - (3) All Auxiliary Bishops
 - (4) All Titular Bishops assigned, either by the Apostolic See or by the Episcopal Conference, for special tasks in the country.

These Council members have deliberative voting rights.

- b. The following are also members with the right to be summoned:
 - (1) All Vicars General
 - (2) All Episcopal Vicars
 - (3) All rectors/presidents of Catholic universities
 - (4) All rectors of ecclesiastical faculties
 - (5) All deans of faculties of theology
 - (6) All deans of faculties of Canon Law
 - (7) Some major Superiors of Religious Institutes for men and for women
 - (8) Some major Superiors of Apostolic Institutes for men and for women
 - (9) Some rectors of major seminaries/schools of theology

The manner of choosing these members who are undetermined as to their number, shall be in accordance with the provision of Section II, No. 1 of this Directory.

These Council members have consultative voting rights.

- c. The following may be called to the Council:
 - (1) All resigned Titular Bishops
 - (2) All retired Titular Bishops

When they participate in the Council, they have deliberative voting rights.

- d. The following may also be called to the Council:
 - (1) Some selected members of the clergy
 - (2) Some selected members of the religious
 - (3) Some selected members of the laity

The manner of choosing these members who are undetermined as to their number, shall be in accordance with the provision of Section II, No 1 of this Directory.

When they participate in the Council they have consultative voting rights.

The Episcopal Conference may also invite others as guests to observe and witness the Council proceedings.

When they participate in the Council, they have no voting rights.

3. Presidency of the Council

The Council is to be presided by a President who is elected from among the diocesan Bishops who are members of the Conference.

His election is subject to confirmation by the Apostolic See.

4. Voting Categories

There are two categories of votes exercised by the voting members of the Council: deliberative and consultative.

Deliberative votes are those endowed with decision-making power.

Consultative votes are advisory in nature. Although not binding on the Council, these votes must be seriously considered by the Council members with deliberative voting rights because they may also reflect collective wisdom and prudence.

One summoned to the Council as a participating member thereof by reason of more than one title, has but one vote be this deliberative or consultative.

5. Conciliar Attendance

Attendance in person is mandatory for all those who are summoned to the Council, unless a legitimate impediment prevents them from such a personal attendance. In such a case, the summoned member should duly notify the Council President.

Those who are summoned to the Council with deliberative voting rights but are prevented from attending it by reason of a just impediment may send their proxies. Their proxies however have but consultative voting rights. Those who are summoned to the Council but have only consultative voting rights are not allowed to have proxies when they cannot personally attend the Council for legitimate reasons — except lay persons who are given the privilege of having previously named/identified proxies to be confirmed by the Bishop concerned. These proxies likewise have consultative voting rights.

6. Normative Effect of Conciliar Decisions

The Council is endowed with the power of governance, specially-legislative authority. The acts and decrees of the Council, after their review by the Apostolic See and upon their promulgation and effectivity, have a binding force on the particular Churches and/or the Episcopal Conference concerned.

Section II: Particular Provisions

1. Modification of Membership and Participation

To ensure a wide sectoral attendance in the Council but at the same time giving due consideration to the demands of procedural order and the limitations of the physical facilities of the Council site, the following further modification on conciliar membership and

participation is made:

- a. All resigned and all retired Bishops shall be called to the Council. They are however entirely free to opt to attend the Council or not.
- b. Among the major Superiors of religious institutes for men and for women in active life, only the following are to be summoned to the Council: Those who locally head religious institutes of either pontifical or diocesan right with at least fifty professed members, elected through relative majority votes by and among themselves, with the actual number of those thus elected not exceeding one half of their total number.
- c. Among the major Superiors of societies of apostolic life for men and for women, only the following are to be summoned to the Council: Those who locally head apostolic institutes of either pontifical or diocesan right with at least fifty professed member, elected through relative majority votes by and among themselves, with the actual number of those thus elected not exceeding one half of their total number.
- d. Among the rectors of major seminaries, only the following are to be summoned to the Council: Those who head theology seminaries and/or seminaries with theology departments.
- e. All the highest local heads of secular institutes of pontifical right shall be called to the Council with consultative voting rights.
- f. All the lay executive officers, committee chairpersons, council members and the members of the advisory council of the Council of the Laity of the Philippines shall be called to the Council with consultative voting rights.
- g. All the lay presidents or heads of duly recognized national Catholic organizations, associations or movements shall be called to the Council; with consultative voting rights.
- h. All the lay heads of diocesan pastoral councils, or the equivalent of these pastoral entities, shall be called to the Council with consultative voting rights.

 The conciliar President, taking into account the significance of a given occasion, the nature of a particular Council agenda or the emergence of a peculiar situation, may invite guests to the Council, the actual number of whom may not exceed three at any given time.

Membership in the Council in whichever category becomes official through receipt of the formal summons, call or invitation, signed by the President and the secretary general of the Council

- 2. Officers of the Council
- a. Conciliar President

The conciliar President, elected by two-thirds majority of the members of the CBCP present and voting in plenary assembly, and in the event of any subsequent incapacitating or disqualifying factor, succeeded by the conciliar Vice-president or the Alternates from Luzon, the Visayas or Mindanao in this order, has the following functions and responsibilities:

- (1) He is responsible for the over-all management of the affairs pertinent to the conduct of the Council.
- (2) He sees to it that the established norms, provisions and procedures of the Council are carried out faithfully, without prejudice to his faculty to dispense from particular procedural matters for a just cause and with the concurrence of the conciliar Vice-presidents specifically in order to facilitate the work of the Council.
- (3) He organizes the different tasks and activities required to carry out the work of the Council and monitors the implementation of these tasks and activities.
- (4) He appoints, with the concurrence of the conciliar Vicepresidents, the Secretary General of the Council.
- (5) He appoints, with the concurrence of the conciliar Vicepresidents, the chairperson of the standing committees and secretariat of the Council.
- (6) He appoints, with the concurrence of the conciliar Vicepresidents the chairperson and the members of the board of consultants for the Council, with which he communicates, or which he convenes and consults as needed.

- (7) He presides at and moderates the plenary sessions according to the established norms and procedures, authorizes the holding of regional sessions at the instance of the Vicepresidents, and ordains the holding of needed provincial sessions with the concurrence of the Vice-presidents.
- (8) He gives his concurrence to the appointment of the Bishopmembers of the conciliar commissions by their Bishop chairmen.
- (9) He monitors the order and the progress of the work of the conciliar commissions.
- (10) He signs together with the Secretary General and thus authenticates official Council instruments and documents.

b. Conciliar Vice-presidents

The conciliar Vice-presidents, one each from Luzon, the Visayas and Mindanao, with their respective alternates, elected by absolute majority of the members of the CBCP present and voting in plenary assembly, have the following functions and responsibilities:

- (1) They call the regional sessions of the Council, with the concurrence of the President, whenever they consider these necessary or convenient.
- (2) They preside at and moderate the regional sessions of the Council according to the established norms and procedures, and bring the session tasks to fulfillment.
- (3) They preside at and moderate plenary sessions by turns, when requested by the President, according to established norms and procedures.
- (4) They assist the President in monitoring the work of the conciliar commissions.
- (5) They attend to other conciliar concerns or tasks entrusted to them by the President.

c. Conciliar Secretary General

The conciliar Secretary General, appointed by the President with the concurrence of the Vice-presidents, has the following functions and responsibilities.

- (1) He assists the President in the day-to-day direction of the various tasks and activities of the Council. Together with the President, he signs and thus authenticates official Council instruments and documents.
- (2) He directs the activities of the conciliar committees and coordinates their work.
- (3) He appoints, with the concurrence of the President, the assistant secretary general and the members of the conciliar committees and secretariat.
- (4) He assumes responsibility for the administrative requirements of the Council.
- (5) He creates ad hoc committees appoints their heads and members as may be required to carry out particular tasks and activities, and/or to attend to certain concerns and needs of the Council.

d. Conciliar Assistant Secretary General

The conciliar assistant secretary general assists the Secretary General in the latter's functions and responsibilities, and attends to other conciliar activities or tasks given him by the same.

- 3. Conciliar Commissions, Committees, Board and Secretariat
- a. Conciliar Commissions

The conciliar commissions that attend to, study and make pronouncements on the main thematic agenda of the Council are the following in the order of thematic treatment:

- (1) Commission on Christian Life
- (2) Commission on Religious Concerns
- (3) Commission on Social Concerns
- (4) Commission on the Church and Society
- (5) Commission on the Laity
- (6) Commission on the Religious
- (7) Commission on the Clergy

The primary task of the conciliar commissions is the preparation of the position papers on their respective thematic agenda that will serve as the working instruments of the Council.

Every conciliar commission is headed by a Bishop chairman who is elected by absolute majority of the members of the CBCP present and voting in plenary assembly.

Every Bishop-chairman appoints with the concurrence of the President, two Bishop-members. Every Bishop chairman also appoints as many experts and advisers as may be required by the commission. While they are not members of the Council, with the permission of the conciliar President however, said experts and advisers may presence (sic) any regular or special session of the Council held for the presentation of, discussion and/or deliberation on the "position paper" of the conciliar commissions they serve.

b. Conciliar Committees

The standing conciliar committees are the following with their-corresponding responsibilities:

(1) Committee on Liturgy and Fellowship:

It takes charge of all conciliar liturgical/paraliturgical acts and community gatherings/celebrations.

(2) Committee on Communication:

It acts as the official media arm of the council, issues approved media releases and makes required press presentation/representations on behalf of the Council.

(3) Committee on Documentation:

It executes into writing the documents referred to it by the Council, rearranging and/or recomposing them in a suitable style, as the case may be.

(4) Committee on Ways and Means:

It attends to conciliar requirements regarding physical arrangements and facilities, kitchen services and the like, and looks after the personal needs of the Council members, like health care, communications, transportation and the like.

(5) Committee on Procedures and Order:

It sees to the proper observance of procedural provisions, the resolution of procedural questions and the imposition of sanctions for misconduct, violation of norms, and the like.

Every committee is headed by a chairperson appointed by the Secretary General with the concurrence of the President.

Every chairperson appoints, with the concurrence of the Secretary General their lay, religious or cleric members.

c. Board of Consultants

The chairperson and members of the board or consultants are all appointed by the President with the concurrence of the Vice-presidents.

The board of consultants provides the needed doctrinal and/or technical expertise regarding issues, doubts and problems brought to it by the President, the Vice-presidents and the commission chairmen.

d. Secretariat

The secretariat is headed by a chairperson appointed by the Secretary General with the concurrence of the President.

The ex officio members of the secretariat are all the chairpersons of the conciliar committees, and others whose services are needed, the same to be appointed by the secretariat chairperson with the concurrence of the Secretary General.

The secretariat provides the staff requirements of the Council. It serves as the coordinating center among the various standing conciliar committees. It also renders such services as recording, storage and filing of documents and materials, typing and reproduction, composition and production of minutes and chronicles, and general administrative functions.

Section III: Procedural Guidelines

1. Conciliar Sessions

Conciliar sessions are of three kinds, be these regular or special sessions, i.e. called according to the ordinary or extraordinary schedule:

- a. Plenary when all the participants gather in one and the same hall at the same time for a session presided and moderated by the President or the designated Vice-president according to established norms and procedures.
- b. Regional when the participants from Luzon, the Visayas and Mindanao gather in given halls at given times according to these geographical territories for a session presided and moderated by the Vice-president from Luzon, the Visayas and Mindanao respectively, according to established norms and procedures.
- c. Provincial when the participants from the different ecclesiastical provinces gather in given halls at given times according to these ecclesial divisions for a session presided and moderated by their respective Metropolitans according to established norms and procedures.

2. Interventions

- a. Interventions may differ in intent as well as in content. Some interventions may be intended to draw official action or decision, such as "motions" and "seconds." On the other hand, there are interventions that may be intended simply to obtain clarification such as questions, points of order or the like.
- b. In plenary sessions, only those with deliberative voting rights can legitimately raise official motions and give seconds thereto. Any participant however may make clarificatory interventions. In regional and/or provincial sessions, all participants with voting rights may give interventions of any kind. Nevertheless, specifically for purposes of approving or disapproving seconded motions in these sessions only participants with deliberative voting rights can legitimately cast their votes.

- c. It is the presiding officer of the session, be this plenary, regional or provincial, who has the prerogative to open the period of interventions, to recognize the intervenors, and to decide on the appropriateness and relevance of interventions accordingly.
- d. A participant who is desirous of intervening during a session must first register his proposed intervention, intent and content with the session secretariat that shall note, schedule and call it during the session. In principle, no intervention shall be entertained that not follow this procedure.
- e. A participant, after having already delivered an intervention on a given matter or issue, may not intervene again until after all other intervenors on the same matter or issue shall have made their respective interventions.
- f. The delivery of interventions may not last more than three minutes unless the presiding officer allows an extension thereof at the instance of the intervenor which, in any case, may not be more than two additional minutes.
 - g. Interventions categorically seeking to propose amendments must be submitted in writing to the session secretariat. These interventions shall be labelled according to their subject matter and signed by their authors. Such interventions are evaluated and the proposed amendments therein contained are reconciled prior to their delivery on the floor for approval or disapproval.
 - h. Interventions which are non-amendatory are left to the discretion of their authors to submit in writing or not to the session secretariat.

3. Position Papers

a. The seven position papers — called "Final Drafts" during the preparation phase of the Council — prepared by the seven conciliar commissions deal on the following seven conciliar topical agenda: Christian Life, Religious Concerns, Social Concerns, Church and Society, Laity, Religious, Clergy. b. Every position paper that constitutes a major proposal to the Council has the following sections or their equivalents in sequence:

(1) Exposition

It discusses the doctrinal foundations and ramifications of the topic.

(2) Conclusion

It presents the logical implications of the doctine set forthin the first section.

(3) Resolution

It advances practical recommendations and concrete proposals based on the two previous sections.

c. Every position paper goes through the following process prior to its adoption as a final conciliar document:

(1) Presentation

The position paper is brought before the participants gathered in plenary session for presentation through its reading in full or in outline form. This reading has the following intents:

- (a) To formally acquaint the participants with the content of the paper and its significance.
- (b) To provide the participants the opportunity to raise clarificatory questions.
- (c) To subject the paper to an initial judgment of either "acceptance" or "rejection" by the participants concerned. A paper that is rejected after the reading is automatically remanded to the conciliar commission concerned which must subsequently draft an entirely new or a simply revised one for representation. A paper that is accepted after the reading is considered accepted for discussion and deliberation.

(2) Discussion

The position paper that passed the reading is automatically considered submitted for discussion by the participants in particular sessions. This phase has the following purposes:

- (a) To provide the participants with the opportunity to study the paper more thoroughly.
- (b) To enable them to form a better and more informed judgment on the contents of the paper.
- (c) To give them the occasion to formulate common amendatory interventions on the paper for submission during plenary sessions.

(3) Deliberation

The position paper that has passed the reading and that has gone through the discussion in particular sessions is brought for deliberation in plenary sessions. The proposed amendments to the paper are read. These amendments may suggest addition to or deletion of certain items from the paper. They may also proposed correction/reformulation of statements and/or propositions. This stage of the process has the following objectives:

- (a) To decide whether the amendments proposed would be considered singly or in cluster.
- (b) To put to a vote the proposed individual or consolidated amendments.
- (c) To produce a fully accomplished final draft document for the approval of the Council in plenary session.

The lead agent in this entire process is the conciliar commission whose position paper undergoes the above said presentation, discussion and deliberation.

4. Approval

The approval of a final draft document is done according to the following procedures:

- a. Line by line approval
- 28 Boletin Eclesiastico de Filipinas

Each line of the final draft document is approved first.

b. Section by section approval

Every section of the same document is subsequently approved.

c. Approval as a whole

The document in full is ultimately given approval.

This threefold approval which can be given only by the Council in plenary session makes the instrument an official conciliar document.

5. Voting Procedures

 a. It is mandatory for all participants with voting rights to vote on a given question or issue when so required.

Abstentions are not allowed. An abstention is automatically counted as an approval.

b. Open voting is the norm in plenary, regional and provincial sessions.

In plenary sessions secret voting may be allowed on a case-tocase basis provided at least two-thirds majority of the participants present with deliberative voting rights so approve. In regional and provincial sessions, secret voting may likewise be opted on a case-to-case basis provided at least an absolute majority of the participants present with deliberative voting rights so decides.

c. To obtain a vote of approval in plenary sessions, at least twothirds majority of the participants present and casting deliberative votes is required. In regional and provincial sessions a vote of approval is obtained with at least an absolute majority of the participants present and casting deliberative votes.

So that the mind of the participants casting consultative votes may be properly taken into account by the participants with deliberative voting rights, a counting of the consultative votes cast shall be conducted first before the casting of deliberative votes is done.

6. Rules of Order

The Council adopts the Rules of Parliamentary Procedure as its basic guidelines for group proceedings.

As always, however, the overriding consideration in all said working groups are the demands of fraternal charity and mutual respect, of reason and common sense, of collegial consciousness as well as community discipline.

7. Official Language and Attire

English is the official language of the Council. Where technical precision or exactitude is necessary, Latin may be used upon the advice of the board of consultants and the approval of the Council.

For the opening and closing rites of the Council, all the participants are required to wear liturgical, religious or formal lay attire. For plenary, regional and provincial sessions the Council President, with the concurrence of the Vice-presidents, determines and enjoins the proper attire.

8. Public Statements

All matters presented, discussed and deliberated upon, and all judgment and decisions made during any plenary, regional or provincial session should be treated with utmost care and guarded confidentiality prior to their formal release for publication.

The issuance of public statements and media releases is the strict and exclusive prerogative of the conciliar President, his delegate of the purpose, and/or the committee on communications.

AMENDMENTS TO THE DIRECTORY OF PCP II

s proposed by the PCP-II National Coordinating Office and approved by the Catholic Bishops' Conference in its July 1990 Plenary Assembly, the following amendments (italicized) have been made in the PCP-II Directory.

A. Amendment 1: Section I, No. 5, Conciliar Attendance.

"Those who are summoned to the Council with deliberative voting rights but are prevented from attending it by reason of a just impediment may send their proxies. Their proxies however have but consultative voting rights. Those who are summoned to the Council but have only consultative voting rights are not allowed to have proxies when they cannot personally attend the Council for legitimate reasons - except lay persons who are given the privilege of having previously named / identified proxies to be confirmed by the Bishop concerned. These proxies likewise have consultative voting rights."

B. Amendment 2: Section II, No. 2, Officers of the Council, a.

"Conciliar President: The conciliar President, elected by twothirds majority of the members of the CBCP present and voting in plenary assembly, and in the event of any subsequent incapacitating or disqualifying factor, succeeded by the conciliar Vice-President or the Alternate from Luzon, the Visayas or Mindanao in this order, has the following functions and responsibilities."

C. Amendment 3: Section III, No. 2, Interventions, b.

"In plenary sessions, only those with deliberative voting rights can legitimately raise official motions and give seconds thereto. Any participant however may make clarificatory interventions. In regional or provincial sessions, all participants may make interventions of any kind. Nevertheless, specifically for purposes of approving or disapproving seconded motions in these sessions, only participants with deliberative voting rights can legitimately cast their votes.."



PCP II ORGANIZATIONAL STRUCTURE

Officers of the Council

Conciliar President

- he conciliar President, elected by two-thirds majority of the members of the CBCP present and voting in plenary assembly, has the following functions and responsibilities:
 - 1. He is responsible for the over-all management of the affairs pertinent to the conduct of the Council.
 - 2. He sees to it that the established norms, provisions and procedures of the Council are carried out faithfully, without prejudice to his faculty to dispense from particular procedural matters for a just cause and with the concurrence of the conciliar Vice-presidents specifically in order to facilitate the work of the Council.
 - 3. He organizes the different tasks and activities required to carry out the work of the Council, and monitors the implementation of these tasks and activities.
 - 4. He appoints, with the concurrence of the conciliar Vicepresidents, the Secretary General of the Council.
 - 5. He appoints, with the concurrence of the conciliar Vice-presidents, the chairpersons of the standing committees of the Council.
 - He appoints, with the concurrence of the conciliar Vice-presidents, the chairperson and the members of the board of consultants for the Council, with which he communicates, or which he convenes and consults as needed.

 - 7. He presides at and moderates the plenary sessions according to the established norms and procedures, authorizes the holding of regional sessions at the instance of the Vicepresidents, and ordains the holding of needed provincial session with the concurrence of the Vice-presidents.
 - 8. He gives his concurrence to the appointment of the Bishopmembers of the conciliar commissions by their Bishop chairmen.
 - He monitors the order and the progress of the work of the conciliar commissions.

10. He signs together with the Secretary General and thus authenticates official Council instruments and documents.

Conciliar Vice-presidents for Luzon, Visayas and Mindanao

The conciliar Vice-presidents, one each from Luzon, the Visayas and Mindanao, elected by absolute majority of the members of the CBCP present and voting in plenary assembly, have the following functions and responsibilities:

- 1. They call the regional sessions of the Council, with the concurrence of the President, whenever they consider these necessary or convenient.
- 2. They preside at and moderate the regional sessions of the Council according to the established norms and procedures, and bring the session talks to fulfillment.
- They preside at and moderate plenary sessions by turns, when requested by the President, according to established norms and procedures.
- 4. They assist the President in monitoring the work of the conciliar commissions.
- 5. They attend to other conciliar concerns or tasks entrusted to them by the President.

Conciliar Secretary General

The conciliar Secretary General, appointed by the President with the concurrence of the Vice-presidents, has the following functions and responsibilities:

- 1. He assists the President in the day-to-day direction of the various tasks and activities of the Council. Together with the President, he signs and thus authenticates official Council instruments and documents.
- 2. He directs the activities of the conciliar committees and coordinates their work.

- 3. He appoints, with the concurrence of the President, the assistant secretary general and the chairperson of the conciliar comittee and secretariat.
- He assumes responsibility for the administrative requirements of the Council.
- He creates ad hoc committees as maybe required to carry out particular tasks and activities and/or to attend to certain concerns and needs of the Council.

Conciliar Assistant Secretary General

The conciliar Assistant Secretary General assists the Secretary General in the latter's functions and responsibilities, and attends to other conciliar activities or tasks given him by the same.

Conciliar Commissions, Committees, Board and Secretariat

Conciliar Commissions

The conciliar commissions that attend to, study and make pronouncements on the main agenda of the Council are the following in the order of thematic treatment:

- 1. Commission on Christian Life
- 2. Commission on Religious Concerns
- 3. Commission on Social Concerns
- 4. Commission on the Church and Society
- 5. Commission on the Laity
- 6. Commission on the Religious
- 7. Commission on the Clergy

The primary task of the conciliar commissions is the preparation of the position papers on their respective thematic agenda that will serve as the working instruments of the Council.

Every conciliar commission is headed by a Bishop-chairman who is elected by absolute majority of the members of the CBCP present and voting in plenary assembly.

Every Bishop-chairman appoints with the concurrence of the President, two Bishop-members. Every Bishop-chairman also ap-

points as many experts and advisers as may be required by the commission. While they are not members of the Council, with the permission of the conciliar President however, said experts and advisers may presence (sic) any regular or special session of the Council held for the presentation of, discussion and deliberation on the "position paper" of the conciliar commissions they serve.

PCP II PROCESS SCHEMATIC PRESENTATION

Cardinals, Archbishops, Bishops, Priests, Religious Sisters and Brothers, Laymen and Laywomen are conciliar participants upon receipt of the pertinent summons.

The Second Plenary Council of the Philippines is scheduled to be held from 20 January to 17 February 1991.

In its Plenary Assembly held at Tagaytay City on 29 January 1990, the Catholic Bishops' Conference of the Philippines approved a number of proposals regarding the forthcoming Second Plenary council of the Philippines. They also approved the issuance of decrees of convocation, conclusion, and promulgation. The decree of convocation was released last 28 February 1990, while the other decrees are still under preparation. PROFILE OF THE SEVEN CONCILIAR AGENDA

he choice of the seven topics which comprise the agenda of the Second Plenary Council of the Philippines was made by the Bishops based on the results of the nationwide survey conducted by the National Coordinating Office of the Council. They reflect the perceived concerns of the faithful of the Catholic Church in the Philippines.

The seven topics are meant to relate with one another, thereby avoiding overlapping of fields while providing the needed integration with the overall thrust of the Council. The interrelation of these seven topics is described below.

The Christian Life. Since the aim of the council is the renewal of the Catholic Church in the Philippines, and the Church is a living communion of persons professing the Faith and putting it into practice in their lives, the Christian life is the ultimate beneficiary of this conciliar process. The Christian life entails the integration of the Catholic Faith in the daily lives of the Filipino Christian.

Religious Concerns and Social Concerns. The Christian life, in turn, can be viewed under two aspects: religious concerns (distinct from the "religious state or persons" which is the seventh conciliar agenda) and social concerns of the believing Filipino.

Religious Concerns involve the ongoing thrust and process of evangelization, of which catechesis is an integral part. How are the religious values to be better inculcated to the faithful? How can they live them better?

Social Concerns take cognizance of the fact that the Christian is in the world and is an integral part of civil society. His religious concerns are not merely private concerns but must have an effect on his fellow men and in the structures of the world.

Church and Society. The first three topics certainly involve some issues of an ecclesial and societal nature, which have to be tackled on the national level - the level of the Catholic Church in the Philippines in the concrete Philippine society in which it subsists. Hence, the topic on Church and Society dovetails with the first three conciliar agenda.

Laity, Religious, Clergy. Finally, the agents and subjects of all these are the Christian faithful, which consists of three categories of persons.

The Laity are the ordinary Catholic faithful, comprising the vast majority of the Church, and who should be the ultimate agents and beneficiaries of a renewal of the Church. They are characterized by their secular (i.e., immersion in the world) character and have their proper role in the Church, especially in the Christianization of the temporal order.

The Religious are those men and women who profess the evangelical counsels and are thereby constituted as qualified witnesses of the Christian message, each one according to the proper charism of his or her institute. The importance of the religious in the renewal of the Catholic Church in the Philippines can be gleaned from their number and from the many apostolic works which depend on them.

The Clergy are all those who, through the sacrament of Orders, form part of the hierarchy. They are the religious leaders of the faithful, and have a crucial role in the formation of all the faithful.

CIVIL MARRIAGE OF CATHOLICS

missionary religious priest has sent us the following two cases as questions on civil marriage. We answer them briefly and refer our readers to a short study on civil marriage which follows the answer to these two cases.

I. A Catholic is civilly married to a pagan. How can the marriage be convalidated?

Our advise is to celebrate a real and true marriage in accordance with the Church Law (can. 1108) after a dispensation of the impediment of disparity of cult has been obtained. We imply and assume that there is no danger of perversion for the Catholic party in contracting this marriage; otherwise the divine law forbids this kind of marriage.

Some authors sustain that a convalidation in radice is also possible. We doubt this, since civil marriage for Catholics, according to the traditional Church's view, is not even regarded as an invalid marriage, but rather as an inexistent marriage. How can, then, an inexistent marriage be "convalidated" in radice? Only invalid marriages are convalidated (c.1163).

II. Two Catholics are civilly married only. One of them wants by all means to have their living together legalized in the Church; the other is opposed to this idea. What do you suggest in order to help them?

We presume that the living together of these two Catholics is required for the protection of their children; otherwise, the best solution would be to part ways and discontinue radically their sinful life. The well disposed party, however, "wants by all means to legalize their living together in the Church." They can try to request a
